4. VAT is levied in compliance with the effective legislation of the Russian Federation.
5. When providing services of reloading in-flight catering, the payment of 3900 rouble is charged including VAT for each reload.
6. In case of flight delay the payment of 3 200 roubles is charged including VAT for each catering delivery to Terminal 1, Terminal 1A, Terminal 2
7. Delivery of flight catering to the aircraft by purpose-designed vehicle - 3 200 roubles including VAT.
8. Catering delivery services by foot courier at order of:  
up to 5 portions - 800 rub. Including VAT  
from 6 up to 10 portions - 1 400 rub. including VAT  
from 11 portions and more - 1 500 rub. including VAT
9. In case of any discrepancies between two language versions of the tariffs, the Russian language version will prevail.
